In the name and on behalf of the citizens of the county of Dawson and the State of Georgia, charges and accuse **NYDIA PINZON TISDALE** with the offense of **OBSTRUCTION OF AN OFFICER (FELONY)**, for that the said accused in the County of Dawson and the State of Georgia, **ON THE 23<sup>RD</sup> DAY OF AUGUST, 2014**, did unlawfully knowingly and willfully resist and oppose Captain Tony Wooten of the Dawson County Sheriff's Department, a law enforcement officer in the lawful discharge of his official duties, by offering and doing violence to such officer by elbowing said officer in the face and kicking said officer in the shin while being lawfully escorted off of the property located at 5 Burts Farm Road aka Burt's Pumpkin Farm, in violation of O.C.G.A. § 16-10-24(b), contrary to the laws of said State, the good order peace and dignity thereof.

## COUNT TWO

AND THE GRAND JURORS, aforesaid, in the name and on behalf of the citizens of the county of Dawson and the State of Georgia,, charge and accuse **NYDIA PINZON TISDALE** with the offense of **OBSTRUCTION OF AN OFFICER (MISDEMEANOR)** for that the said accused in the County of Dawson and the State of Georgia, **ON THE 23<sup>RD</sup> DAY OF AUGUST, 2014**, knowingly and willfully obstruct and hinder Captain Tony Wooten of the Dawson County Sheriff's Office in the lawful discharge of his official duties by refusing to leave the premises at 5 Burts Farm Road aka Burt's Pumpkin Farm when asked to do so by Captain Wooten, who was an authorized representative of the property owner in making that request, in violation of O.C.G.A. § 16-10-24(a), contrary to the laws of this State, the good order, peace and dignity thereof.

## COUNT THREE

AND THE GRAND JURORS, aforesaid, in the name and on behalf of the citizens of the county of Dawson and the State of Georgia,, charge and accuse **NYDIA PINZON TISDALE** with the offense of **CRIMINAL TRESPASS** for that the said accused in the County of Dawson and the State of Georgia, **ON THE 23<sup>RD</sup> DAY OF AUGUST, 2014**, knowingly and without authority remain upon the land and premises of another person, to-wit: Johnny Burt, located at 5 Burts Farm Road aka Burt's Pumpkin Farm, after receiving notice from Tony Wooten, acting as an authorized representative of the owner, Johnny Burt, to depart, in violation of O.C.G.A. § 16-7-21(b)(3), contrary to the laws of this State, the good order, peace and dignity thereof.
