Re: Demand for Retraction and Notice to Cease and Desist Internet Defamation

Dear Mr. Simon:

Please take note that our firm has been retained by Senator Brandon Beach to investigate and take legal action against you for the series of unwarranted and defamatory acts made against him by you on your website. Specifically, that website is www.securecampaigner.com doing business as *Political Vine dot com*, www.politicalvine.com.

Senator Brandon Beach has been a state senator since 2013. He has provided his constituency with outstanding and thoughtful representation. He conducts himself with the highest integrity, decorum, and abides by all the laws and rules that apply to his position of trust. Senator Beach has established a well-

founded reputation for his statesmanship, honesty, and constituent satisfaction. Your unwarranted postings and false statements that accuse Senator Beach of accepting bribes have damaged his reputation and adversely affected Senator Beach's work in the Georgia Senate and for the people he represents. A copy of those postings and referenced PDF are attached.

You have personally posted willfully false and misleading statements about Senator Beach. Examples of those statements include the follows:

- "Lesson to learn: When you bribe* KEY legislators, be sure you do it fairly."
- "[L]ast Saturday's edition of the Political Vine, which provided a
 detailed account of who got how much in bribes* from casino (via
 this compiled PDF report "2017 Casino Bribe* Report."
- You state that Senator Beach has taken "\$7000" in "bribes";
- You state that Senator Beach pulled back his Casino Bill because other senators were not bribed enough.
- You specifically cite to the Georgia Bribery Statute, O.C.G.A. § 16-10-2, but omit its entire context. For example, part (a)(1) of that statute refers to "any benefit, reward, or consideration to which he or she is not entitled with the purpose of influencing him or her in the performance of any act related to the functions of his or her office or employment; or" By law, obviously, politicians may accept lawful political contributions and are thus legally "entitled" to accept such contributions.

Moreover, when you email the *Political Vine* to others, you caption it as follows, and notably omit your asterisk:

Your statements and your implications that Senator Beach has taken or somehow condoned bribes are false, libelous per se and defamatory. Those accusations are malicious and unfounded in fact and in law. As you well know, political contributions are legal in Georgia, and politicians are entitled to accept contributions, so by definition they are not bribes. Your statements and attribution of bribes to Senator Beach are defamation per se because they depict our client as engaging in felonious behavior that violates Georgia law. Your use of the out-of-context "*" does nothing to diminish your attribution of multiple felonies to Senator Beach. We suspect that your intent is for your readers to only see the word "bribe," which is why you used it twenty times in the defamatory online publication. The small asterisk, intentionally used by you to conflate unlawful bribes with lawful political contributions, in no way diminishes the defamatory nature of your statements.

You actively encourage receipt of and solicit defamatory statements from your readers. As a result of your repetitious use of the word "bribes" you have significant financial exposure to Senator Beach for each and every one of the defamatory statements made by your visitors. *Fair Housing Council of San Fernando Valley v. Roomates.com, LLC,* 489 F.3d 921 (9th Cir. 2007).

Your efforts to spread malicious, libelous, and defamatory material about Senator Beach have caused serious and irreparable injury to him, his reputation, and his work for his constituents. He will not stand by idly and allow this misconduct to continue.

We hereby demand that you:

- 1. Immediately remove from any and all of your websites all defamatory and disparaging remarks regarding Senator Beach and "bribes" made by you or any visitors to your site.
- 2. Immediately cease and desist in publishing any defamatory statements about Senator Beach, whether the statements were made by you or published by any third parties;
- 3. Issue and immediate full and complete public retraction and remove any reference to the word "bribe" or "bribes." The retraction must be sent to *every* email recipient of your defamatory email entitled: "Rumors have it . . . Casino Bribes—Update!... 02-27-2017."
 - 4. Compensate Senator Beach for his attorney's fees and costs.

Note well that neither this law firm nor Senator Beach attempt to restrict rightful and legitimate free speech. The internet is an amazing tool and has changed the world. But like all tools, it must be used responsibly and fairly. Your false and unlawful attribution of a "bribe" to Senator Beach is neither responsible nor fair. They are unlawful and impinge upon Senator Beach's rights for no other reason than you wish to be sensational and to smear his name.

You have until March 30, 2017, to comply with our four demands. If you do not comply, we will recommend that Senator Beach take legal action, and that he pursue all available legal and equitable remedies. Those would include all permitted by law, including compensatory and punitive damages, and attorney's fees and costs that he incurs because of your defamatory actions.

Obviously, this is a serious matter. It requires your immediate attention. We recommend that you contact us after you have received this letter so that you can immediately address these very important issues. Our expectation is that this letter is the one and only pre-suit notice that we will give.

Govern yourself accordingly.

Several years ago, the executives of the various Utility companies (read "regulated monopolies") in Georgia successfully sued the State to overturn the law that previously prohibited them from being able to contribute money to members of the Public Service Commission.
